

## STUDENT FIRST AID PRIVACY POLICY FOR UNDER 13s

We know that your data is precious and we will keep it on our system for a short time, to let you complete your training and print out copies of your certificate.

If you are **under 13 years of age**, you can still do the course, but you must ask a parent or legal guardian to complete the consent form, before you enter your name or email address onto this website. If you are doing the course at School you will need to give the consent form to your teacher before you sign up for the course.

If you would like to complete the free Online Student First Aid course, we will need to know a little about you.

We will need:

- Your First Name and Last Name
- Your email address (or an email address that you have permission to use)

Why do we need this?

- We need your full name for your certificate
- We need an email address to send you your login information or provide you with assistance

How long will we keep the information you provided?

We will only keep the information about you for 30 days after you have finished the course, our legal basis (reason) for processing your data is legitimate interest, so that we can provide you with a course that you want to take.

Please don't forget that if you forget to print out your certificate or need a copy, you will only be able to log back in and print a copy for a limited time.

Data stored is secure and all systems in place, comply with the new GDPR regulations and EU-US Privacy shield, so that your name and email address is secure for the short time we have it.

Parental consent forms are only retained for the duration of the training and for 30 days after certification.
